Background

The root causes of health inequities reside in decisions made outside of the health sector. For example, global systems governing trade, extractive industries and private finance increasingly shape countries' ability to improve health equity.

The Lancet-University of Oslo Commission on Global Governance for Health (2014) drew attention to these political origins of health inequalities. The University of Oslo then established **The Independent Panel on Global Governance for Health** to follow-up and advance the research and policy agenda identified by the Commission.

This conference is the first of three international conferences the Panel will organise to bring together academics, policymakers and civil society representatives to discuss how global politics shape inequities in health.
